ARTWORK MAY BE DROPPED OFF JANUARY 27, 2015 FROM 11AM TO 5PM OR JANUARY 28, 2015 FROM 11AM TO 5PM.

THE EXHIBIT WILL RUN JANUARY 30, 2015 THROUGH FEBRUARY 24, 2015 WITH AN OPENING RECEPTION TO BE HELD ON FRIDAY, JANUARY 30, 2015 FROM 5 TO 7 PM.

ONCE RECEIVED BY THE WCAC, ALL ARTWORK WILL BE INSURED FOR 70% OF ITS RETAIL VALUE AS INDICATED ON THE GALLERY INVENTORY LIST UNTIL IT HAS BEEN SOLD OR RETURNED TO THE ARTIST.

ALL WORK MUST BE AVAILABLE FOR SALE. THE WCAC, A NON-PROFIT AGENCY, RETAINS A 30% COMMISSION ON ALL WORKS SOLD DURING THE EXHIBIT.

THE WCAC IS NOT RESPONSIBLE FOR DAMAGE RESULTING FROM POOR WORKMANSHIP, DEFECTS OR LACK OF QUALITY CONTROL BY THE ARTIST.

CONDITIONS:

HANGING WORKS SHOULD BE PROPERLY WIRED WITH EYE HOOKS PLACED APPROXIMATELY 1/3 FROM THE TOP OF THE WORK AND FRAMING WIRE OF APPROPRIATE WEIGHT SHOULD BE USED (NO SAW TOOTH HANGERS, PLEASE). ALL WORK MUST BE LABELED ON THE BACK WITH ARTIST NAME, TITLE, AND PRICE.

THE WCAC WILL NOT EXHIBIT ANY WORK THAT IS PRESENTED IN AN UNPROFESSIONAL MANNER AND RESERVES THE RIGHT OF FINAL REVIEW ON ALL WORK ONCE IT HAS BEEN DELIVERED.

WORK CANNOT BE WITHDRAWN BEFORE THE END OF THE EXHIBIT.
