

# Call for Artists



The Washington County Arts Council invites all art educators in Washington County's public and private schools to enter work for the February 2020 exhibit. This is an invitational exhibition and all work will be accepted. Each educator can submit **three works** that have been completed within the last two years. Artwork may be dropped off Friday, January 31, 2020 from 11am to 5pm, Saturday, February 1, 2020 from 10am to 4pm, or Tuesday, February 4, 2020 from 11am to 5pm.

The Exhibit will run from February 6, 2020 through March 3, 2020. An opening reception will be held on Thursday, February 6, 2020 from 5pm to 7pm.

All entries are to be received by WCAC no later than 5pm on Tuesday, February 4, 2020.

## Liability:

Once received by WCAC, all artwork will be insured for 70% of its retail value as indicated on the gallery inventory list until it has been sold or returned to the artist.

All work must be available for sale. The WCAC, a non-profit agency, retains a 30% commission on all works sold during the exhibit.

The WCAC is not responsible for damage resulting from poor workmanship, defects or lack of quality control by the artist.

## Conditions:

Hanging works should be properly wired with eye hooks placed approximately 1/3 from the top of the work and framing wire of appropriate weight should be used (no saw tooth hangers, please). All work must be labeled on the back with artist name, school, title, and price.

WCAC will not exhibit any work that is presented in an unprofessional manner and reserves the right of final review on all work once it has been delivered.

Work cannot be withdrawn before the end of the exhibit.
